



#### **COOPERATION AGREEMENT**

# BAKU ENGINEERING UNIVERSITY THE STATE AGENCY ON RENEWABLE ENERGY SOURCES

Baku city 04 July 2023

Baku Engineering University (hereinafter referred to as the "University"), operating on the basis of its Charter and represented by Rector Havar Mammadov on one side, and the State Agency on Renewable Energy Sources (hereinafter referred to as the "Agency"), operating on the basis of its Statute and represented by Director Cavid Abdullayev on the other side, hereinafter collectively referred to as the "Parties", have reached an agreement on establishing cooperation at the initial stage of the specialist training process in the following areas:

### 1. Purpose of the Agreement

The purpose of this Agreement is to establish joint cooperation in the training of specialists in energy, electronics, and automation-related fields at the University.

## 2. Areas of Cooperation

- 2.1. The Parties shall cooperate in the field of specialist training at the University in the following directions:
- 2.1.1. Support by the Agency for enriching the information resources of the University's library and information system;





- 2.1.2. Provision of opportunities for lectures dedicated to various topics to be delivered to the University's students and staff by the Agency's senior officials, leading specialists, and invited foreign experts;
- 2.1.3. Provision of opportunities for the organization of internships for the University's students within the structures of the Agency;
- 2.1.4. Involvement of the Agency's senior officials and leading specialists in teaching specific subjects on a part-time or hourly basis at the University, supervising graduation theses and master's dissertations, and participating in state certification commissions and specialized councils;
- 2.1.5. Creation of opportunities for participation of the Agency's employees in events organized at the University, and for the University's staff and students to attend events organized at the Agency;
- 2.1.6. Creation of career opportunities for University graduates within the structures of the Agency;
- 2.1.7. Organization of excursions for University students to the structures of the Agency;
- 2.1.8. Support by the Agency for scientific-research activities conducted at the University.

# 3. Terms of Implementation of the Agreement

3.1. The cooperation activities mentioned above will be implemented without





financial payments between the Parties. If necessary, for example, in the organization of internships, the relations between the Parties will be regulated on the basis of separate agreements.

#### 4. Force Majeure

If one or both Parties are unable to fulfill or are hindered in fulfilling any obligation under this Agreement due to natural disasters, strikes, public unrest, rebellion, war, decisions of state authorities, or other unforeseen circumstances beyond the control of the Parties, the period for fulfillment of obligations shall be extended until the consequences of such events are eliminated. If the force majeure lasts more than 30 (thirty) days, the other Party shall have the right to terminate the Agreement immediately by written notice.

#### **5. Other Provisions**

- 5.1. This Agreement shall enter into force on the date it is signed by the authorized representatives of both Parties.
- 5.2. This Agreement is signed for a period of 5 (five) years. If necessary, it may be re-drafted or amended by mutual written consent of both Parties. After the initial 5 (five) years, it may be extended for another 5 (five) years by mutual agreement of the Parties.
- 5.3. Either Party may terminate this Agreement by notifying the other Party





at least 6 (six) months in advance, without any obligation or compensation.

5.4. This Agreement is prepared in two copies in Azerbaijani and English. All copies have equal legal force.
